SLP (CIVIL) Diary No(s). 5555/2025

1. Delay condoned.
2. Leave granted.

3. The order dated 10.04.2026 passed by the Government of Chhattisgarh is placed before us. The said order reads as follows:

"No. F 20-3/2019/1-3: In supersession of this department's orders of the same number dated 11.07.2024 and 31.01.2025, the State Government, in compliance with the final order dated 16.04.2024, passed by the Hon'ble High Court of Chhattisgarh, Bilaspur, in W.P. (PIL) No. 91/2019 and W.P. (S) No. 9778/2019 along with other similar writ petitions [W.P. (S) No. 839/2020, W.P. (S) No. 3600/2020, W.P. (S) No. 286/2021], filed against provision of reservation in promotion of government servants belonging to the Scheduled Castes and Scheduled Tribes of the state, and in accordance with the legal precedents set by the Hon'ble Supreme Court in "Jarnail Singh and others Vs. Lachhmi Narain Gupta and others reported in (2018) 10 SSC 396, M. Nagraj and others Vs. Union of India and others reported in (2006) 8 SSC 212 and Jarnail Singh case (Supra)", hereby constitutes the following committee to prepare a report on "Quantifiable Data" regarding the provision of reservation in promotions for government servants belonging to the Scheduled Castes and Scheduled Tribes of the state".

4. Pending disposal of the Civil Appeal, the process

as contemplated in order dated 10.04.2026 of the Government of Chhattisgarh, may go on.

5. Counter affidavit, if any, shall be filed before the next date.
